Current Research Project, 2017-2022

Storying Our World: Literary and Pedagogical Narratives of Social Economics

"Storying Our World" argues for the centrality of narrative to shaping and propagating our social understanding of the economy. The project starts from the current shift in economics, gathering momentum since the 2008 Financial Crisis, the 2015 United Nations Sustainable Development Goals, and 2015 Paris Climate Accord, towards "human economics": the understanding of the economy as principally concerned with the well-being and sustainability of family, community, and the environment rather than the market, growth, and competitive development.

My hypothesis is that, while social scientists say we need a radical re-invention of political economy, there are an abundance of stories that already enact the values we need and want. I argue that human economics is best found in the humanities, which have always focused on culture, ethics, ideology, and belief. Examples include: community collaboration over individualistic competition; well-being over financial wealth; sustainability rather than extraction; generosity rather than greed; circular economy rather than eternal growth; a work-to-live not live-to-work ethic.

This project is founded on the belief that the most powerful stories, and thus those most likely to activate the shift to human economics, are the most popular, international, and mainstream stories. PHOÖ English students make an ideal cohort: 'typical' millennials, with access to Anglo-American popular culture, with adequate language competence and professional interest in the pedagogical power of story. Human economists, like proponents of ecological sustainability, all argue for the importance of changing the unsustainable political economy now for the benefit of future generations. Thus, the corpus must be developed by PHOÖ students (and potentially their students), to reflect the stories that are meaningful and relevant to the way they see the world.
